6:30 Chairman Ian Arnold called the meeting to order

6:35 Report from Captain Paul Koetitz, Salt Lake City Fire Department

- Private fireworks in Salt Lake City are NOT ALLOWED in No Fireworks Zones:
 East of 900 E, north of South Temple, and west of Redwood Rd. All sky lanterns are prohibited. Protect your neighborhood with a No Fireworks Zone sign available from the fire department.

6:45 Report from Bryan Jensen, District 6 representative of the Salt Lake School Board of Education

- After careful consideration by the Board and other stakeholders, Dr. Elizabeth Grant was selected as the SLC School District's new Superintendant. She will replace the Interim Superintendant, Dr. Martin Bates, starting this summer on July 1st.
- Tops on the district's list is student safety. There have been two separate occurrences this spring involving a gun on school grounds. The district will fulfill Dr. Bates' promise to install weapons detectors in all of the high schools. This stringent and expensive measure is required to keep our teenagers safe given the proliferation and easy accessibility of guns these days. The Board also wants to add to the current eight School Resource Officers working district-wide.
- Although many parents voiced the opinion they would like to keep online virtual classes available as an option to traditional, in-person classes, only 66 students were using it last spring. As such, virtual classes will be discontinued next school year.
- Through the district's Child Nutrition Department, meals are available to all children, regardless of income status. Find locations, times, menus, and more at the department's website:

- The Board is currently engaged in a Population and Boundary Study of **ALL** district elementary schools, divided by quadrants, for possible boundary realignment or school closure. After 1-1/2 years of open houses and opportunities for public comment, the Board is developing a list of viable options for potential boundary changes or school closure. The Options Committee will present the recommended options to the Board in July. The Board will hold a public hearing on the matter in December. 7:15 Andrew Smith, Parley's Canyon Gravel Mining Update

• Mr. Smith lives at the mouth of Parley's Canyon, on the north side, and his family owns a cabin in Mt Aire Canyon. He is bringing the threats of fugitive dust, water pollution, and environmental disruption from the mine to the public's attention.

- Jesse Lassley, owner of Tree Farm has submitted plans to develop his 632-acre parcel on the south side of Parley's Canyon for a rock and gravel mine. KSL News ran this article with information:

- Salt Lake County has voted to prohibit extraction in Forestry/Recreation zones. Tree Farm, LLC is now suing SL County.
- Utah Department of Air Quality intends to approve the mine's air-quality plan. In their flawed method to assess the risk of windborne dust, not only did they use a model based on only 20 acres, but they used a wind indicator station at the Salt Lake airport, rather than any of the three wind indicators within Parley's Canyon.

7:30 Dan Dugan, District 6 City Council Representative monthly report

- City Council Member Amy Fowler, District 7 (Sugarhouse) has resigned due to the demands of her legal practice that will require her attention in Sanpete County at length. Her seat is expected to be filled in a November election.
- The city budget for the next year has been approved with a 5% increase from \$448M in 2022.
- The free bus passes for students program will be enhanced. Last year 778,000 free rides were given, and they expect a 28% increase next year.
- For those experiencing homelessness, some sanctioned camping is allowed. Officials monitor the locations to try to reduce their problems and maintain sanitary conditions. New permanent housing is going in. The state has begun supporting the efforts with legislation and funding, recognizing homelessness is not simply a Salt Lake City problem.
- Dan and other SLC staff visited Miami, Florida to observe results of their 20 year-old program to address
 homelessness. SLC's criminal recidivism is high because they have no home to go back to after serving time.
 Also criminal justice here is handled by the many local jurisdictions, rather than a central, overseeing court. This
 makes compliance more difficult for parolees. SLC is now trying to relieve pressure on police and fire
 departments by utilizing more resource officers, social workers, and EMT's to handle street crises.
